### FRG: Applications in Classification

Program of the 8th Annual Conference of the (German) Society for Classification, Hofgeismar, April 10-13, 1984

The program comprises an opening lecture and 40 papers, evenly distributed between the application interests in numerical and in non-numerical (conceptual) classification. The meeting is organized in 3 plenary and 14 parallel sessions. The membership assembly takes place on April 11th and a visit to historical Hofgeismar in the evening of the 12th.

#### U.K.: CRG Meetings 245 and 246

The 245th meeting took place on Oct.20th, 1983 at the Library Association. The meeting expressed its congratulations to *Dr.Austin* on the award of the degree of Ph.D. by the University of Sheffield.

The finalization of some features of general structure in the 2nd ed. of the Bliss Classification was discussed, especially the problem of common and special subdivisions and the problem of phenomenon classes and their citation order.

The 246th meeting was held on December 8, 1983 at the Library Assoc. in London with a presentation by Mrs.J.Aitchison and Mrs.J.Dahlberg on the Intercocta Project. For the planned new international encyclopedia of the social sciences a structured way of displaying knowledge via systematically arranged glossaries is sought. Mrs.Dahlberg explained the concepts lying behind a categorization system which leads to a socalled "systematifier" applicable for a predictable arrangement of concepts of each knowledge/subject field. A handout showing an example of application of the systematifier in the field of ethnic studies was discussed. The group stressed the necessity of defining correctly a subject field in order that its concepts may be recognized and systematized properly.

#### USA: ASIS/SIG/CR Plans

In the SIG/CR Newsletter CR-18 of Jan.1984 plans brought forward at the business meeeting on Oct.3, 1983 for the ASIS Mid-Year Meeting 1984 in Bloomington, Indiana are reported. Suggestions had been made with respect to possible programs featuring software for teaching classification and indexing and for thesaurus construction. Proposals for sessions at the 1984 Annual Meeting in Philadelphia included programs on problems encountered when traditional cataloging is computerized, as in public access catalogs, as well as future directions in bibliographic description, problems of international data banks and measurement and evaluation of controlled vocabularies.

## **Cultural Development**

Experts Meeting on Methods for Analysis and Evaluation of Thesauri of Cultural Development, Zagreb, Sept. 1983

Some 14 representatives of 8 countries (Belgium, France, Hungary, Poland, Romania, Switzerland, URSS and Yugoslavia) met at the Institute for Culture of Croatia, Zagreb, Yugoslavia Sept.26-30, 1983 to discuss questions toward the exchange of information via the establishment of a common thesaurus in the field of

culture. The meeting sponsored by UNESCO, in particular its Division of Cultural Development was organized by Mr.Miroslav Tudjman, who served also as its chairman. It was already a second meeting in this problem area, the first one with the theme: "Preparation of National Thesauri of Cultural Development" had taken place March 23-25, 1981, also at Zagreb. (See the Proceedings volume: National Thesauri of Cultural Development. Zagreb: Institute for Culture of Croatia 1982. 160p.)

The participants presented brief reports on the progress of the work on national thesauri and on the tests with the International Thesaurus (ITCD) (by Jean Viet) in each country. The ITCD has already been translated into Croatian, Hungarian, Polish, Portuguese, Romanian, Russian, Spanish; a provisional German version exists and translations into Dutch and Arabic are being prepared. Also, the African Cultural Institute is developing a version for Africa. The results of the meeting are summarized in a Final Report. #### ECSSID WG3 Meeting, Bonn, Oct 1983

On 17 and 18 Oct.1983 a general meeting of ECSSID (European Coordination Centre for Research and Documentation in Social Sciences) Working Group 3 took place in Bonn with 15 representatives from 9 countries. It was organized by the Vienna Centre (Mr. Soloviev) and hosted by the Information Centre in Social Sciences (IZ) (Dr.K.Stroetmann, Mr.W.von Lossow). Prof. V. Vinogradov, WG3 Chairman, presided at the meeting. The WG3 is concerned with compatibility of information systems and languages. A report on an earlier meeting in Prague 1980 has been published in IC 1981-1, p.32.

Some 7 papers and reports were given. The meeting concluded with 12 recommendations concerning policy and future work, among which the following items:
