

Foreword

The first edition of this book on the rigths of anthroposophic medicine appeared, in German, in 2007. Its aim was to flank my “Homöopathie und Verfassungsrecht [Homeopathy and Constitutional Law]”, published in 2004, with a counterpart in another central area of recognized specific therapeutic approaches. While the associated constitutional-law approach narrows the focus, it brings the advantage that amid the medical difference of opinions it can show a secure legal foundation, which with a national Constitution is of course the case. The second edition presented here, in English translation too, derives its importance from the Declaration of Rights of Anthroposophic Medicine developed by anthroposophic medicine in 2011. It is to this that the particularly important twelfth chapter of this book is devoted. The human-rights foundation of this Declaration, and thus its international roots, has made a separate text on the importance of human rights in the health sector necessary (Chapter 5).

The English-speaking reader of this book on the right of anthroposophic medicine should not overlook the point that the law presented is first and foremost German law, and therefore a foreign area for readers from other countries. Though the presentation does not stop at German law but goes in detail into the relevant European Community law and the international human-rights guarantees, the basic reference to German law remains. However, the reader need not balk at this. Nowhere else is the content of the right of anthoroposopfic medicine so highly developed and so differentiated as in Germany. Bearing in mind that the German word in the title, Recht, has a double meaning corresponding to the English words “law” and “right” and thus refers not only to claims but also to the justified self-perception of anthroposophic medicine, it will become clear that the recourse to German law is not intended to be a sort of self-presentation but is instead an endeavour to put forward the exemplary nature of the German provisions for the international recognition of anthroposophic medicine. Obviously, the reference to German law as the starting-point has not been left at that. As already mentioned, German law – along with others – is embedded in European Community law. To that extent, there is a legal view independent of German law. This is even more so when universal human rights are brought into this study. Nonetheless, while a whole number of specifically German questions from the first edition have not been taken over into the English version of this second edition, there is still quite a lot of German law left. The reader will accordingly even in purely formal terms have to struggle with the German abbreviations for laws and technical literature that have been used. There would

have been no sense in converting these into English, since the result would be sequences that simply do not exist in German legal usage. The reader is accordingly referred to the list of abbreviations, where an English translation is given for the German abbreviations. While publications in German have been translated into English in the footnotes, so that the reader will know whether the topic might be of interest to him at all, you should not fall into the error of assuming that these are English original texts. Accordingly, texts translated into English are followed by a (g) to indicate that the original is in German.

I must particularly thank Christa Hebisch of IKAM (the International Co-ordination of the Movement for Anthroposophic Medicine). Christa Hebisch was of indispensable assistance to me, thanks to her worldwide experience with legal regulations for medicinal products and the political situation surrounding them but particularly also because of her years of wide-ranging legal work for anthroposophic medicine in various international organizations, in checking what I had written. Her unfailing commitment in an honorary capacity to the rights of anthroposophic medicine was both a model and an inspiration for me. I also have to thank Iain Fraser for the translation into English. He has translated the often not simple anthroposophic terminology into English in outstanding fashion. And finally, I wish to thank Stefan Simonis, who has very generously included the English text in the publications of the NOMOS-Verlag publishing house.
